



Let's hope we don't meet again(!) But I know the rest of the women who do will be very lucky for your support." "I just wanted to add, the support you have been giving me has actually provided a light at the end of this 20 year long tunnel and now my children are starting to see me get stronger and the improvements in everyone is awesome. I could never express how grateful I am for your help and support."

"Today I had a victory of sorts. It's never a win when the outcome is to have a DVO granted, but the validation of standing up for the safety and peace of yourself and family is definitely a prize worth pursuing. I wanted to say a massive thank you to you for the support and advice that you have offered me over the past few months. We only met and spoke briefly on two occasions but the courage and hope that you gave me to keep fighting for what was right kept me going."

"Thank you again for your support having someone actually understand that I know the right things to do but emotionally I'm not coping was amazing."



We have court again in August to hopefully, seamlessly get this order in place. I have an appointment with women's legal services. Our journey is far from over, though for a moment I can breathe and actually feel the sunshine and its warmth. Thank you again for your support and guidance and that of all your colleagues. I am so grateful for all the work that you do."




